Tips: Get the most out of your doctor's visit

-Call ahead to schedule an appointment, most places don't take walk-ins, and with walk-in's you'll probably wait longer to see the doctor

-Important documents to bring: ID (driver's license or school ID), immunization record, school or sports physical form, proof of address, insurance card if you have one

-Write down any questions you have before the visit, so you remember to ask

-Bring in any medicines you take regularly, or any that need refills

-Be honest with the doctor, so they can give you the best medical care possible

Reminder about confidentiality law:

-Anything you discuss with a medical professional (your doctor) is confidential, meaning your doctor will not share this information with your parents, friends, or anyone else without your consent. The only time your doctor needs to tell someone else is when you say you might hurt yourself or hurt someone else, and this is for your safety. Your doctor encourages you to involve an adult you trust in your medical care.

Reminder about consent in DC:

You have the right to consent to: testing and treatment for STD's, including HIV, contraceptive services, prenatal care and delivery services, abortion, drug or alcohol abuse counseling and medical care, outpatient mental health care.

# JOIN DC CAMPAIGN

**Teen Town Halls** give young people the opportunity to share their opinions, their priorities, and their visions for the community. Organizations interested in hosting a Teen Town Hall agree to recruit 30 teens, between the ages of 14-18 and provide space for the meeting. **Spreading the Word** is a weekly e-newsletter that reaches over 700 people interested in youth development/teen pregnancy prevention activities, programs and research.
